Article VII

Qualifications Of ASC Service Positions

Section 6:

- A. At least 3 years continuous clean time
- B. Preferred service experience
- C. Familiarity of financial accounting experience

Article VIII

Duties of Officers and Chairs

- A. To be co-steward of the ASC funds
- B. To perform monthly of the Area checkbook and bank statements
- C. To assist the treasurer in his/her duties and attend all ASC meetings
- D. In the event that the treasurer is unable to complete their term, to act as treasurer for the term, with a vote of confidence from the floor
- E. To automatically become Treasurer at the completion of the current Treasurer's term, with a vote of confidence from the floor
