Greetings Family,

Good news, the plan instituted by the RSO Board is showing progress.

Although the office showed a fiscal year end loss of \$1,688 the fourth quarter posted a gain of \$1,659. It looks like all the hard work and effort to get things turned around is starting to pay off. They are continuing to monitor the business closely, looking for other improvements. The RSO Manager mentioned a couple of upcoming obstacles. First of all because the gross sales for the year was down \$75,000 from the previous year, it was likely the RSO will lose 1.25% discount on next year's contract from the WSO. Additionally Bank of America has raised their credit card processing fees by .25%(point 25%). Because of this the office is urging their customers to pay by check when possible to help keep costs down.

The RSC Meeting Ad Hoc was created last RSC. They are directed to examine the service committee structure of the region and the feasibility of simplifying the administrative duties of the region. Some of the topics mentioned were reducing the number of RSC's each year and reducing the need for Subcommittee chair's to spend the night. We are going to ask that they look at the budget approval timeline so that the home groups have the opportunity to vote. If you have any idea of suggestions on improvements please let your RCM team know as soon as possible.
