The Region was very Thankful to our Area for hosting the region. The South Central Area will be hosting the Regional the next time we meet. We renegotiated our contract with Howard Johnsons. We are pleased that we were able to keep Regionals held at a central location for the next year. We will meet January 12th, April 13th, July 13th, and October 12th of 2013 each date is the 2nd weekend of every quarter.

The Region gave Audit Report, I am glad to report that the books balanced there was \$14,800.00, after the budgets and housekeeping was tallied the Region will be making a donation of \$6,125.00 to NAWS. We received three Insurance Quotes for \$15,000.00, \$12,341.00, and \$950.00. The two larger Quotes are more full coverage and the one smaller quote is more of liability coverage. The region has asked for a consensus of what the Region would like them to do that there may be coverage of some kind for groups that may not have coverage for there groups or functions they hold.

Two matters of the RSO were addressed:

1st - There was a Directive made that the RSC Executive Committee hire a new CPA for the Show-Me-Regional Service Office to go over the books, that we may have one standard of accountability, there was a discovery of two standards being used.

2nd there was a Motion presented by an Area to the region to close the RSO.
