Motion#20240114-04 reads: To add the word "for" instead of the coma after "Regional annual expenses" in 6.4.b.

Motion# 20240114-05 reads: To add to Regional P&G 6.4.a "all budgets must be submitted to regional Treasurer before the end of April RSC." Intent: To allow for time to prepare budget for July RSC.
